GENERAL INSTRUCTIONS

All candidates in the 2010 Local School Council (LSC) elections and all nominees for appointment must complete this questionnaire.

Section 105 ILCS 5/34-2.1 requires that each person nominated as a candidate for a Local School Council position disclose if he or she has been convicted of any of the offenses listed below. **Candidates need not disclose any convictions of the Juvenile Court.** Students must only disclose any convictions if they were tried and convicted as an adult. Failure to make such disclosure shall render a person ineligible for election to a Local School Council.

Failure of an LSC nominee or prospective appointee to an LSC to complete this form shall render the nominee ineligible for election or appointment to the LSC.
