Shared an update on SY26 LSC Elections, including:

- Election Timeline:
  - Candidate application window opened on October 20
  - Applications due January 20
- Application Data:
  - Over 900 applications submitted as of the meeting date - Only 9 student applications
  - Noted the need to significantly increase student candidate participation
- Reapplication Reminder:
  - Current members must reapply to serve in the next term; service is not automatic
- AppDash Competition:
  - Districtwide initiative to encourage early candidate applications and school-based recruitment
- Candidate Workshops:
  - Three upcoming workshops (two in English, one in Spanish) focused on campaign readiness
    - Dates Jan 27 - Feb 3 (spn) and Feb 10
- Election Judge Recruitment:
  - Ongoing need for approximately 2,000 judges
  - Stipend increased to \$325, inclusive of food allowance
- Student Leadership Initiatives:
  - Launch of the LSC Student Ambassador Program to support student recruitment and engagement

- Provided Clarification of student voting rights and eligibility

Members also asked clarifying questions regarding:

- Staff elections as non-binding preference polls
- Student elections as binding and one-year terms
- Vacancies are created when student members leave a school mid-term

LSC Needs Assessment Discussion -

    - Different section that focuses on each stakeholder's unique areas of concern (i.e., Student - how do you give a diplomatic report when the principal is on the council, but you see a problem within the school)

- Timeline
  - A. Shannon wants to go after January
  - Townhalls - Earl Grandberry -
    - One town hall at each network.
    - Changes to regions
    - Earl Grandberry says at least one per region
    - The focus group should be a response to the survey
    - K. Ford clarifies that E. Grandberry introduces a new idea- focus group vs townhall. (mini listening sessions)
    - Once a survey comes out, you get data, and use that data to get focus groups.
    - K. Ford offers feedback at the listening session.
