- 1. Yolanda Morris -More programs should be put in the existing schools, safety concerns about children crossing over into other areas.

5. Adourthus McDowell-I think it's outrageous that the school will not have a LSC in the first year.

- 1. **Bing**-population shrinkage, schools are no longer full-- less full schools, less funds to provide resources/programs.
- **Chief Higginbottom**-safety has been taken into account. Transportation will be provided for impacted students as well as bus aides.
- 2. **Bing**-Due to student based budgeting, the fewer students in the building, the fewer resources available.
- 3. **Sherry Eagle**-Our partners feel that working with several schools would diminish the resources, whereas working with one school with 650 students would be more concentrated and impactful.
- 4. **Bing-**My office was put in place to have conversations around what parents and the community wants. We are solving for more resources for students--not staff.. LSC and the District would be responsible for hiring the Principal, and the Principal would hire school staff. None of this is an effort to misplace students.
- 5. **Chip**-It is state and federal law that new schools don't have LSCs for four years.
