- 1. Concealed raceways are preferred by CPS. In renovation projects when concealed raceways are not possible, provide surface mounted raceways.
- 2. Coordinate the placement of raceways with millwork, furniture, equipment, etc. installed under other sections or by others.
- 3. Coordinate rough-in locations of outlet boxes provided under Section 26 05 33.16 Boxes for Electrical Systems and conduit provided under Section 26 05 33.13 Conduit for Electrical Systems as required for installation of raceways provided under this section.
- 4. Verify minimum sizes of raceways with the actual conductors and components to be installed.
- 5. Wall Duct: Coordinate the work with other trades to provide walls suitable for installation of flush-mounted wall duct where indicated.
- 6. Notify Architect/Engineer of Record of any conflicts with or deviations from Contract Documents. Obtain direction before proceeding with work.

#### B. Sequencing:

- Do not install raceways until final surface finishes and painting are complete.
- 2. Do not begin installation of conductors and cables until installation of raceways is complete between outlet, junction and splicing points.

#### 1.04 SUBMITTALS

- A. See Section 01 30 00 Administrative Requirements, for submittal procedures.

- 1. Wireways: Provide dimensioned plan and elevation views including adjacent equipment with all required clearances indicated.
- D. Manufacturer's Instructions: Indicate application conditions and limitations of use stipulated by product testing agency. Include instructions for storage, handling, protection, examination, preparation, and installation of product.

- B. Perform work in accordance with NECA 1 (general workmanship).
- C. Install raceways plumb and level.
- D. Arrange wireways and associated raceway connections to comply with the City of Chicago Electrical Code, including but not limited to requirements for deflected conductors and wireways used as pullboxes. Increase size of wireway where necessary.
- E. Secure and support raceways in accordance with Section 26 05 29 Hangers and Supports for Electrical Systems at intervals complying with the City of Chicago Electrical Code.
- F. Close unused raceway openings.
- G. Provide grounding and bonding in accordance with Section 26 05 26 Grounding and Bonding for Electrical Systems.
- H. Identify raceways in accordance with Section 26 05 53 Identification for Electrical Systems.

# 3.03 FIELD QUALITY CONTROL

- B. Inspect raceways for damage and defects.
- C. Correct wiring deficiencies and replace damaged or defective raceways.

#### 3.04 CLEANING

A. Clean exposed surfaces to remove dirt, paint, or other foreign material and restore to match original factory finish.

A. Protect installed raceways from subsequent construction operations.
